### \* CITIZENS REDISTRICTING COMMISSION

The 14 member Independent California Citizens Redistricting Commission will hold a public input meeting in Oakland on May 21, 2011, from 2:00 p.m. - 5:00 p.m. in the City Council Chambers. The Commission was created by California voters to draw state Congressional, Assembly, Senate and Board of Equalization Districts. Public participation in drawing these districts is critical to ensuring that communities have the strongest voice possible to express their preferences. The League strongly supported the development of this Commission so here is a chance to give input.

The Commission is taking testimony from local area residents before drawing its first round of draft maps which will be released in June. Final district maps must be certified by the Commission and presented to the Secretary of State by August 15, 2011.
